Chair thanked Councillor Marshall for his diligence as the Returning Officer for the election, and welcomed the new members of the D&DCC.

- Minutes of the Last Meeting held 19 Oct 22. The minutes were proposed and 1. agreed.
- 2. Matters Arising. Chair proposed that, in the interest of brevity, most routine items would be discussed at the next routine meeting. However, Chair explained that updates were required for a few items in view of recent developments. Agreed.

Treasurer's Report and Foundation Scotland Update. Treasurer presented her report.

The Current Account had a balance of £2549.94. £263.57 remained in the COVID Fund, £1,000 was reserved for the resilience boxes upgrade, and £361.76 remained in the Jubilee Fund. This left a working balance of £9245.61 in the Current Account.

The Project Fund balance was £552.21. Treasurer had received a cash donation of £272.50 from the Feuars from last year's car boot sales, and this was used to make a donation to the Denholm Brownies, enabling them to attend the Panto in Hawick. A donation was also made to fund Christmas treats for the village children.

The Community Fund had a balance of £10,125.35, some of which would be used to support the Denholm Folk Festival. There remained two years' funding (£8,000 each) with Foundation Scotland (FS) - the CC was not permitted to hold more than two years' funding at any time.

There were no outstanding invoices.

- **Defibrillators.** It was proposed that money be allocated from the FS a. Treasurer funds to pay for new pads for the Minto defibrillator.
- Christmas Grants. Chair proposed the following grants for the b. Christmas season: £100 to the Brownies & Rainbows (see above); Treasurer £50 to the Cubs and Beavers; £50 to the Bairns Christmas party.

4. Petanque on The Green. Following submission of photos of sample holes dug to show no danger to exposed tree roots, SBC had given planning permission for the petanque to go ahead using a mechanical digger, but again with conditions. Specifically, a temporary fence was to be installed so as to protect the trees and tree roots from accidental damage. CC Hutchings kindly offered to investigate sourcing and erecting a suitable temporary fence.

Wind Farms Update. Chair gave a summary of the latest variations in planning applications relating to Pinesburn, Teviot, Fawside, Millmoor wind farm projects, plus early notification of a further proposal for a "Borders Wind Farm", due for scoping in the new year.
